LAKE GENEVA PROJECT UPDATE: The blue area of the map produced by Clay County GIS, illustrates the different areas designated for the removal of trees from the lake bed. As of the time of this printing, Clay County Purchasing is drafting an agreement for areas 1,3 & 4 to go before the Clay County Commission at their Feb.10th meeting for approval. These areas would get timbered with the debris piled and burned within the budget and current funding for the Lake Geneva Restoration Permit. Once approved we are hopeful the contractor could begin work right away.

The SOLO Board, Clay and Bradford County Staff, the City of Keystone Heights and others are continuing efforts to source additional funding to, at a minimum, get areas 2 & 5 also timbered while the contractor is still on site. Piling of debris may involve volunteers with burning by an approved agency within the permit timeframe.

TREATMENT AREA: Photo 1(above): Aerial photo of Treatment Area taken 1/28/26. The placement of the treatment media is now complete in all of the cells. The plants in cells 5 & 6 have not yet been installed but will be when there is sufficient rain. Technicians are currently completing the installation of control systems which will allow both remote and automatic operation of the water treatment process. Photos 2 & 3 (as are located above) show the white gravel being installed on the top of the berms of the treatment cells. This will provide a driving surface for maintenance access to the treatment cells, the system's piping, valves and controls.
